

## PERUTUSAN SETAHUN SEJAK PELANCARAN NACP 2019-2023 29 JANUARI 2020

- 1. Di dalam menilai prestasi Kerajaan Pakatan Harapan memerintah negara sejak Mei 2018, perkara yang paling ketara yang menampakkan impak dan kesannya adalah usaha mempertingkatkan governans, integriti dan antirasuah.
- 2. Hari ini Perdana Menteri Malaysia tidak lagi dibabitkan dengan tuduhan mencuri dana awam untuk kepentingan peribadi. Imej kleptorat yang disebut-sebut masyarakat dunia sebelum ini telah berjaya dikikis untuk Malaysia kembali dihormati kerana integriti. Secara langsung, kedudukan Malaysia meningkat dari tangga ke 61 ke 51 di Indeks Persepsi Rasuah (CPI) 2019 seperti yang dilapor *Transparency International Malaysia (TI-M)* baru-baru ini.
- 3. Dalam masa setahun sejak pelancaran Pelan Antirasuah Nasional (NACP) 2019-2023, pelbagai usaha telah kita laksanakan dengan terancang dan terperinci. Ia bermula dengan mewujudkan satu badan khusus yang bertanggungjawab untuk menyelaras semua usaha Kerajaan dalam membudayakan integriti dikalangan rakyat. Pada masa yang sama ia juga merancang strategi terbaik untuk memerangi rasuah. Badan ini menjadi pusat penting yang menasihati Kerajaan tentang langkah-langkah terbaik yang diamalkan oleh negara-negara maju dan sekaligus menjadi tanda aras yang diletakkan oleh Pertubuhan Bangsa-bangsa Bersatu (PBB).
- 4. Kita juga mewujudkan satu Jawatankuasa Khas Kabinet Mengenai Antirasuah (JKKMAR) yang juga dianggotai bersama oleh Ketua Setiausaha Negara, Ketua Pengarah Perkhidmatan Awam, Peguam Negara, Ketua Audit Negara dan semua Ketua Setiausaha Kementerian. Pusat Governans, Integriti dan Antirasuah (GIACC) bertindak sebagai sekretariat kepada Jawatankuasa ini yang telah menghasilkan pelbagai dasar untuk penambahbaikan pentadbiran.
- 5. Pelancaran Pelan Antirasuah Nasional (NACP) pada 29 Januari 2019 adalah permulaan kepada usaha membasmi rasuah di dalam struktur yang terancang. Atas usaha dan kerjasama semua pihak, setakat ini 25 inisiatif

telah berjaya kita selesaikan daripada 115 yang dirangka untuk dilaksanakan antara tahun 2019-2023. (Inisiatif penuh seperti dalam lampiran). Ini baru tahun pertama pelaksanaan NACP dan kita telah pun dapat melihat pencapaiannya. Apa yang penting daripada jumlah inisiatif-inisiatif ini adalah perubahan dalam sistem dan institusi kita yang akan menentukan agar usaha-usaha ini berterusan dan ada kesinambungannya dan bukan hanya kerja bermusim.

- 6. Selain daripada itu, usaha-usaha kita ini juga telah mendapat pengiktirafan diperingkat antarabangsa dan pengalaman dan inisiatif yang telah kita laksanakan kini menampakkan kesannya.
- 7. Tahniah dari saya kepada semua pihak yang terlibat dalam menyokong usaha Kerajaan untuk menjadikan Malaysia dikenali kerana integriti dan bukan kerana rasuah. Syabas kepada semua agensi yang menggalas tanggungjawab sebagai badan penting yang melaksanakan dan memantau pelaksanaan Pelan Antirasuah Nasional (NACP).
- 8. Semoga usaha murni kita ini akan mendapat rahmat dan keberkatan Illahi dan Malaysia terus dihormati dan disanjungi.
